

## TERMS AND CONDITIONS "OFFER AT SHOPEEFOOD WITH HSBC CREDIT CARDS" (This Terms and Conditions takes effect from 05/05/2023)

Customers are advised to note that participating in the Promotion program or accepting the promotional benefits offered by the program means that Customer has read, understood and accets these Terms and Conditions.

- 1. The "Offer at ShopeeFood with HSBC Credit Cards" Promotion (the "Promotion") is applicable at ShopeeFood and takes effect from 05/05/2023 to 28/02/2024 (the "Promotion Period")
- This Promotion is applicable for customers who satisfy all of the following conditions: ("Eligible Customer" or "Eligible Cardholder" or "Cardholder")
  - **2.1** Promotion is applicable for HSBC cardholders who are holding the following credit cards issued by HSBC Bank (Vietnam) Ltd. ("**HSBC**" or "**Bank**") in Vietnam:
  - HSBC Premier World Mastercard® Credit Card
  - HSBC Visa Platinum Credit Card

(These credit cards shall be referred to as "HSBC Credit Cards" or "Cards")

  - a) The Promotion is not applicable for HSBC Corporate Credit Card.

- At the payment stage, the Eligible Cardholder is required to choose payment method by HSBC
