



TERMS AND CONDITIONS

“EXCLUSIVE PROMOTION FOR IPHONE 18 SERIES PURCHASE WITH AN HSBC CREDIT CARD AT CELLPHONES”

(These Terms and Conditions take effect from 09/09/2026)

Customer is advised to note that participating in the Promotion or accepting the promotional benefits offered by the Promotion means that Customer has read, understood, and accepted these Terms and Conditions.

1. **Promotion Name:** “EXCLUSIVE PROMOTION FOR IPHONE 18 SERIES PURCHASE WITH AN HSBC CREDIT CARD AT CELLPHONES” (“Promotion”) applies to Eligible Customers when purchasing products within iPhone 18 Series on the website <https://cellphones.com.vn/> or the CellphoneS mobile application (“CellphoneS Online”) or at the nationwide CellphoneS store system, as updated at <https://cellphones.com.vn/dia-chi-cua-hang> (“CellphoneS Stores”) (“Sales Channels”), and is administered by DIEU PHUC Trading and Technical Services Company Limited or HTV General Trading Company Limited (“CellphoneS” or the “Partner”).
2. **Promotion Period:** From 00:00 to 23:59 each day, based on Vietnam time (GMT+7), from 09/09/2026 to 31/01/2027 (inclusive of both dates).
3. **This Promotion is Eligible for customers who satisfy all of the following conditions:**
 - 3.1 Cardholders who are holding the following credit cards issued by Bank in Vietnam (“Cardholder”) as following:
 - HSBC Premier Credit Card
 - HSBC TravelOne Credit Card
 - HSBC Live+ Credit Card
 - HSBC Cash Back Credit Card
 - HSBC Livefree Credit Card(These credit cards shall be referred to as “HSBC Credit Cards” or “Cards”)
 - 3.2 This Promotion shall not apply for:
 - By & within the Promotion Period, Cardholders if his/her Credit Card is delinquent with fee, balance at HSBC, blocked for any reasons.
 - HSBC Quasi Credit Cardholder

3.3 Cardholders, who meet the terms and conditions of the Promotion.

Cardholders, who meet the terms and conditions of the Promotion hereafter known as **Eligible Customers**.

4. Details of the Promotion:

4.1 Offer details(“**Offers**”):

During the Promotion Period, Eligible Customers who purchase the Promotional Products (as defined in Clause 4.2) via the Partner’s Sales Channels will be entitled to the following offers:

4.1.1 **Offer 1:** Discount of VND 1,000,000 for an order with an Eligible Product value up to VND 40,000,000.

4.1.2 **Offer 2:** Discount of VND 2,000,000 for an order with an Eligible Product value of at least VND 40,000,000.

4.2 **Eligible Product:** All products under the iPhone 18 Series listed for sale which is distributed by CellphoneS at CellphoneS Web or CellphoneS Store when making payment with HSBC Credit Card. (Hereafter be referred to as “Eligible Product”)

4.3 The Promotion is are available only to the first Eligible Customers who complete payment earliest using an HSBC Credit Card via the Sales Channels, from 00:00 on the first day to 23:59 on the last day of each Phase during the Promotion Period, as follows:

4.4 The Offers will be available to the earliest Eligible Customers as recorded in HSBC’s system, or until the Offers are fully redeemed, whichever occurs first. Any unused Offers in a Phase will be carried over to the next Phase until all Offers are redeemed or the Promotion Period ends, whichever occurs first. Eligible Customers may not receive an Offer if the number of Offers allocated to each Phase or the total number of Offers available for the entire Promotion has been fully redeemed, whichever occurs first.

4.5 How to get the Promotion

4.5.1 At store:

- a. **Step 1:** Customers select Applicable Products and request the staff at CellphoneS offline to apply the Offer, and use one of the HSBC Credit Cards to make payment.
- b. **Step 2:** After confirming that the card is eligible, staff at CellphoneS offline will create the payment order for the Customer. The Offer (if applicable) will be automatically applied and deducted from the order value before the Customer initiates the payment transaction.
- c. Partner's salesman or cashier will inform the Customers on the final amount after discount. Customers agree and make payment by HSBC Credit Card, then, get the product.

4.5.2 At Website:

- a. Select the Eligible Products on the website then click “Buy Now”.
- b. The Cardholder enters the purchase information.
- c. Select the delivery at home or in the store.
- d. Select payment method: Credit Card and input HSBC Credit Card information.
- e. Tick the button: “I agree to CELLPHONE S's privacy agreement and purchasing policy”.
- f. The discount (if Eligible) will be automatically deducted to the final payment amount at the payment step.
- g. Click “Make Payment” to complete the order and wait for delivery.

- 4.6 Each Eligible Customer (based on the HSBC Card and the account registered on CellphoneS) is entitled to a maximum of one (1) Offer throughout the Promotion Period.
- 4.7 The Promotion does not apply to the order shows signs of promotion abuse or violates the Community Standards or CellphoneS Policies at <https://cellphones.com.vn/> , or do not meet the conditions Program requirements.
- 4.8 All information of this Promotion will be fully published on [HSBC's website](#) or [Cellphone's website](#) from 09th September, 2026
- 4.9 The Offer will not be re-issued if an order is cancelled or returned for any reason. The Offer cannot be substituted with other products, redeemed for cash, or transferred in any form.

- 4.10 Cardholder who owns credit card with unactive status should activate their eligible card before participating in this promotion.
- 4.11 Promotion is for retail customers only. HSBC and Partners reserve the right to refuse to apply the Promotion to orders that appear or are proven to be purchased and resold by merchants, including but not limited to: (i) purchasing unusually large quantities; (ii) having a transaction history indicating commercial purposes.
