

TERMS AND CONDITIONS**“BUY 2 TICKETS AT CGV ONLY VND 85,000
WITH HSBC CREDIT CARDS”**

(This Terms and Conditions takes effective from 16/05/2020)

1. The “**Buy 2 tickets at CGV only VND 85.000 with HSBC Credit Cards**” Promotion (“**Promotion**”) shall be effective from **16/05/2020 to 01/08/2020** (“**Promotion Period**”).
 2. Promotion is applicable to customers who meet all the following requirements (“**Eligible Cardholders**” or “**Cardholders**”):
 - 2.1 HSBC cardholders who are holding the following credit cards issued by HSBC Bank (Vietnam) Ltd. (“**HSBC**” or “**Bank**”) in Vietnam:
 - HSBC Premier World Mastercard® Credit Card
 - HSBC Visa Platinum Credit Card
 - HSBC Visa Cash Back Credit Card
 - HSBC Visa Classic Credit Card(These credit cards shall be referred to as “**HSBC Credit Cards**” or “**Cards**”)
 3. **This promotion is not applied:**
 - The Promotion is not applicable for HSBC Corporate Credit Card.
 - Cardholders will not be eligible for this Promotion if his/her Credit Card is delinquent, blocked.
 - Cardholders with card yet to be activated will have to activate their Card prior to purchase.

 - 4.1. **Offer details (“Offer”):** Buy 2 movie tickets (2D) at CGV with **VND 85,000** HSBC Credit Cards every Saturday and Sunday in promotion period
 - Applicable from 7:00 AM to 23:59 on each promotion day, based on Vietnam time GMT +7 and CGV system
 - Applicable for the **first 150 Eligible Cardholders** per day, during Promotion Period
 - 1 eligible cardholder receive 1 offer per month, equivalent 03 offers during promotion period
 - 4.2. The tickets should be for the same movie, same day, same cinema and same seat level (standard or VIP level).
 - 4.3. Eligible transaction is made transaction following as article 5.

- 4.4. The Promotion applies to Eligible Cardholders during the Promotion Day specified at Term 4.1. Eligible Cardholders will not receive the Offer when the number of assigned Offers run out.
5. HSBC and CGV will provide instructions on how customers may obtain the Offer on www.hsbc.com.vn and www.cgv.vn from 16/05/2020.
6. How to receive the discount:
- a. The Eligible Cardholder must sign into their member accounts at www.cgv.vn or on CGV mobile application
 - b. The Eligible Cardholder chooses 1 pair of 2D ticket
 - c. At “discount” section, Eligible Cardholder chooses “Partners”, and chooses “Buy 2 tickets only VND 85.000 with HSBC Credit Card Promotion”
 - d. At the payment stage, the Eligible Cardholder must follow instructions, as shown by CGV, to be entitled to the Offer.
 - e. Eligible Cardholder must present ticket confirmation (email or SMS) at CGV cinema to receive the ticket.
