

TERMS AND CONDITIONS

- 2. Promotion is applicable to customers who meet all the following requirements ("Eligible Cardholders" or "Cardholders"):
 - **2.1** HSBC cardholders who are holding the following credit cards issued by HSBC Bank (Vietnam) Ltd. ("**HSBC**" or "**Bank**") in Vietnam:
