

TERMS AND CONDITIONS

"OFFER IN TIKI WITH HSBC CREDIT CARDS"

(This Terms and Conditions takes effective from 01/05/2020)

- 1. The "Offer in Tiki with HSBC Credit Cards" Promotion ("Promotion") shall be effective from 01/05/2020 to 30/06/2020 ("Promotion Period").
- 2. Promotion is applicable for customers who meet all the following requirements ("Eligible Cardholders"):
 - **2.1** HSBC cardholders who are holding the following credit cards issued by HSBC Bank (Vietnam) Ltd. ("HSBC" or "Bank") in Vietnam:

 - HSBC Visa Classic Credit Card
 (These credit cards shall be referred to as "HSBC Credit Cards" or "Cards")

- Cardholders with card yet to be activated will have to activate their Cards prior to purchase.


3. Promotion Details:

 - Each Eligible Cardholder (based on HSBC Credit Card information and Cardholder email address registered for purchase on Tiki) may only receive the Offer one (1) time only per promotion month.

- 3.2. Each Eligible Transaction are successful purchases with orders valued in accordance with Article 3.1 at Tiki with HSBC Credit Cards and shall not be cancel / refund later
